

Rules for using the Internet resource

These Rules for Using the Internet Resource of wfc2025.kz (hereinafter referred to as the "Rules") are developed to clearly regulate the relationship between the owner and the user of the internet resource wfc2025.kz, as well as to provide a complete understanding of the ways to use the electronic information materials of the internet resource wfc2025.kz (hereinafter referred to as the "Website").

1. The conceptual framework

1.1. The owner of the Website (hereinafter referred to as the "Owner") is the Central Securities Depository Joint Stock Company, which fully exercises the rights to own, use and dispose of the Website.

1.2. The Website User (hereinafter referred to as the "User") is a subject who accesses the Website to obtain the electronic information materials he needs and uses them within the limits defined by these Rules.

1.3. Electronic information materials of the Website (hereinafter referred to as "Materials") – information/materials (including (but not limited to) audiovisual, text, graphic, photographic materials, images, etc.), posted and stored electronically, contained on the Website.

1.4. Use of the Website – any actions of the User on the Website that do not violate the norms of the legislation of the Republic of Kazakhstan.

2. Offer and Acceptance

2.1. Registration and use of the Website by the User constitutes acceptance of this offer, resulting in the conclusion of an agreement between the User and the Website Owner.

2.2. This offer is addressed to an unlimited number of persons and governs the terms of the service for participation in **WFC2025**, which will be held from **23 to 26 September 2025** in **Almaty, Kazakhstan**.

2.3. By registering on the Website, the User confirms that they have read and fully accepted the terms of this offer and agree to participate in the event under the conditions set out in these Rules and on the Website.

2.4. Participation in the Forum is on a paid basis and includes access to the business program, Forum venues, and other related services provided by the Organizer.

2.5. The Organizer reserves the right to change the participation terms, including the event program, registration procedure, and pricing, by publishing the respective information on the Website. All changes take effect upon publication and are binding on Users.

3. General Provisions

3.1. The Owner determines the rules of conduct on the Website and reserves the right to require the User(s) to comply with them.

3.2. Users of the Website are given the opportunity to familiarize themselves with the Materials posted on it and use the Materials, subject to compliance with the requirements of these Rules.

3.3. The User's use of the Website means that the User accepts and undertakes to comply with all the following terms of these Terms. Otherwise, the User should stop using the Website.

3.4. Ignorance of these Rules does not exempt from the need to comply with them and from responsibility.

3.5. These Rules, in whole or in part, may be changed by the Owner at any time without any notice. The new version of the Rules comes into force from the moment they are published on the Website, indicating the appropriate date.

3.6. All comments, complaints and suggestions should be sent to the email address: wfc2025@kacd.kz.

3.7. The Website may contain links to other Internet resources. By clicking on such links, the User assumes full responsibility for the consequences. The User agrees that the Owner is not

responsible in any way for the availability of these resources and for their content, as well as for any consequences associated with the transition to such resources and their use.

3.8. The User provides the Owner with his unconditional consent to the collection (processing) of information related to the User's personal data. At the same time, the Website Owner undertakes to maintain confidentiality regarding the personal data provided by the User.

4. Terms of use of Materials

4.1. The Website contains protected results of intellectual activity, including (but not limited to) objects of copyright and related rights and means of individualization, including texts, photographs, audiovisual materials, graphic images, trademarks, logos, etc.

4.2. The Owner owns the exclusive rights to the Materials, as well as to the selection, arrangement, systematization and transformation of the Materials contained on the Website, as well as to the source data, except in cases separately noted in the content of the Materials published on the Website.

4.3. The use of Materials by the User for personal, non-commercial use is allowed provided that all copyright, related rights, trademarks, and other notices of authorship are preserved, the name (or pseudonym) of the author/copyright holder is preserved unchanged, and the corresponding object is preserved unchanged. The exceptions are cases directly provided for by the legislation of the Republic of Kazakhstan or the user agreements of a particular website of the company.

4.4. The User of the Website has no right to make changes, publish, transfer to third parties, participate in the sale or assignment, create derivative products or otherwise use, partially or completely, the Materials without fulfilling the conditions provided for in these Rules.

4.5. The provisions specified in this section of the Rules provide for the protection of the interests of the Owner and third parties who own the rights to the Materials. At the same time, all holders of rights have the right to exercise their rights specified in these Rules independently.

5. Responsibility

5.1. The users of the Website who have unlawfully used the Materials published on the Website are responsible independently and at their own expense (without involving the Owner of the Website) for unauthorized copying and use of the Materials in accordance with the legislation of the Republic of Kazakhstan.

5.2. The Owner is not responsible for the harm caused to the User by third parties, including through the Website and/or using the Website features.

5.3. The Owner is not responsible for the lost profits, for the loss or damage of the Materials provided by the User, as well as for any events and actions outside the zone of influence of the Owner.

6. Other provisions

6.1. These Rules are regulated and interpreted in accordance with the legislation of the Republic of Kazakhstan. Issues not regulated by these Rules are subject to resolution in accordance with the legislation of the Republic of Kazakhstan. All possible disputes arising from the relations regulated by these Rules are resolved in accordance with the procedure established by the current legislation of the Republic of Kazakhstan, according to the norms of Kazakh law.
